CHANGE TO READ:

ARTICLE XVII, SECTION 17.06, AMENDMENT TO THE BY-LAWS

17.06 No more than six (6) proposition for amendment at a time. If and/or when the proposed amendment(s) is approved, the Central Office has thirty (30) days to make the change(s) to the By-Laws and have ready for issue at the next regular Delegates Meeting. All amendment(s) shall be kept on file with all other changes to the By-Laws.

SECTION XX, PARA. F, AMENDMENT TO THE OPERATING PROCEDURES

f. No more than six (6) proposition for amendment at a time. If and/or when the proposed amendment(s) is approved, the Central Office has thirty (30) days to make the change(s) to the By-Laws and have ready for issue at the next regular Delegates Meeting. All amendment(s) shall be kept on file with all other changes to the By-Laws.

REASON

Due to passed history of amendment(s) not recorded after being accepted (passed), its believed that this should eliminate this problem. Also this will keep the history of the changes up to date.
