**Proposal 06-13: Articles of Incorporation; Section 1;  
The Renaming of the Intergroup.**

**Delegates to vote on in November**

**REASON:**

At the time of the filing the corporate name for the fellowship was entered as "CENTRAL CALIFORNIA FELLOWSHIP OF ALCOHOLICS ANONYMOUS". It may not have been a known fact forty years ago but the name "Alcoholics Anonymous" is a separately owned and registered corporate name with the State of New York. The Central California Fellowship of Alcoholics Anonymous has no right to use the separately owned name in its corporate title.

**CHANGE TO:**

It is the suggestion of Corporate Attorney for AAWS Inc. that if the Intergroup is going to amend the Articles of Incorporation it should change the corporate name as part of that amendment. The following two suggestions were given for a name:

1. Central California Fellowship (CCF)---This name could be useful in the correspondence with the membership and still be within the guidelines of the Traditions of Alcoholics Anonymous,
2. Central California Fellowship of AA (CCFAA)---This could remain the same in all our literature, i.e., By-Laws, Operating Procedures and Policies that is produced at the Central Office.

If this change is made, CCFAA could still call itself Central California Fellowship of Alcoholics Anonymous. An organization can call itself what ever it wants, but the corporate name cannot contain the separately owned and registered name Alcoholics Anonymous.

## Financial Policy

Over the years, Alcoholics Anonymous has affirmed and strengthened a tradition of being fully self-supporting and of not seeking, or accepting, contributions from nonmembers. When outside contributions are received at the General Service Office, they are returned with a note explaining A.A.'s position on the question of self-support.

Within the Fellowship, the amount that may be contributed to the support of movement-wide services by any individual member is limited to \$2,000 a year.

Expenses at the group level for rental of meeting places, coffee and refreshments, literature, etc., are met by "passing the hat." In a majority of groups, an amount is set aside regularly for the support of A.A. world services.

All contributions are voluntary. Membership in A.A. involves no dues or fees. All groups benefit from G.S.O. activities, although not all groups contribute to G.S. O.'s support.

Income from the sale of Conference-approved books and other literature has always been an important factor in the support of G.S.O. services, frequently insuring continuation of those services when contributions from local groups were inadequate.

2. **Central California Fellowship of AA (CCFAA)**---This could remain the same in all our literature, By-Laws, Operating Procedures and Policies that is produced at the Central Office.

If this change is made, CCFAA could still call itself Central California Fellowship of Alcoholics Anonymous. An organization can call itself whatever it wants, but the corporate name cannot contain the separately owned and registered name Alcoholic Anonymous.
