## Growing Up in AA

When I first came to AA, I thought I was much too young to be an alcoholic. I still had some partying to do. But then I went back to drinking, and I thought I was going to lose my mind. I reached a bottom so low I knew there was no hope for me and that I was going to be miserable for the rest of my life. I had just accepted that fact when God intervened, and once again I found myself in an AA meeting. Only this time it was different. I listened to the similarities, not the differences. For the first time in my life, other people understood me. I didn't feel so alone.

At nineteen years old, I was not the youngest member in Alcoholics Anonymous--but I felt like it. I was a scared little girl, very intimidated by the older members of AA. I constantly got comments such as, "You're so lucky to be here at such a young age" or "You seem too young to be an alcoholic." I didn't think I had anything in common with those who were older, and it was very difficult for me to reach out because I felt looked down on because of my age.

But after listening to people share, I realized that alcohol doesn't care what gender, race, religion--or age--we are. Alcohol can get the best of us no matter who we are. I finally realized that if I wanted to stay sober, I had to get past this age thing.

I got a sponsor (who was older than I was) and started working the Steps. I wish I could say that I breezed through all twelve and that my life changed overnight, but it didn't happen that way. Instead, I worked only the Steps I absolutely needed to, and my life stayed insane. What eventually happened was that I reached another bottom.

It says in the Big Book that there will come a time when no human power will be able to stop us from taking a drink. This is true. I had the bottle in my hand. It was only by the grace of God I didn't have to take that drink. I put the bottle down and immediately called another member of the program and from that point on my life really started to change. I dove into the Steps wholeheartedly and did everything that was suggested. I've come to have a strong appreciation and respect for the Steps. They saved my life.

Today I am twenty-three years old and have celebrated four years of sobriety. My life is good. I still have problems and some facts of my life remain the same. What is different is the way I feel about myself. I can honestly say that I love myself.

I'm grateful to those who carried me through my early sobriety, and most of all I'm grateful that I got sober when I did.

Instead of thinking that being young is a handicap, I realize that I have my whole life ahead of me. I don't have to suffer for many years. I can enjoy the things life has to offer.

Now when someone makes the comment "You're lucky to be here so young," I can honestly say, "I know!" with a smile.

**D. Treasurer – Ray L. – February 2008**

**Income**

- Income for February was below budget projections by roughly \$2000. All line items met or exceeded budget year to date.
- The income decline primarily consist of -----
  - AAWS literature sales; \$6,708.08 actual vs \$7,625 projected.\
  - Group contributions declined to \$7,410.78 actual vs \$8,416 projected.
  - Birthday contributions and Office Services revenue both exceeded projection.
  - The newly initiated Faithful Fivers program continues on a very positive note and has contributed an additional \$1,197 to date. Please encourage your group members to participate.
- Gross profit year to date is \$28,484.43 versus \$25,000 budgeted.

**Expense** – Expenses for 2008 will be paid on an “as occurred” basis versus last minute.

- Annual Insurance payments occurred in February, \$1,920, but will be less than budgeted, \$3000, by \$1,080 for the year.
- Office Expense to date is roughly \$1000 higher than projected. This should level off as we proceed through the year.
- Utilities were exceeded by almost \$600 but this will also level off as the year progresses.
- Professional fees were under by \$490 overall due to less than projected Accounting and Network Admin costs.
- Overall Payroll expenses are under by \$2000 as a result of not having an office manager for half of February.
- Total Expenses for the month were \$12,417.25 versus \$12,500 budgeted.
- Resulting Net Income for the month was (-\$854.53) but \$4,393.54 year to date.

For February 2008 Group & individual contributions continue very strong, please continue to encourage that with your groups.

The office staff and the OOC continue to explore ways to increase revenue and reduce expense for 2008.

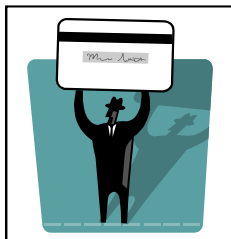
