3 - 10 WEEKLY AA MEETINGS: \$35 PER MEETING

OVER 10 WEEKLY AA MEETINGS: \$300 + \$25 PER MEETING IN EXCESS OF 10

Calculate by the maximum number of meetings your group will have in any given week including monthly speaker meetings

**EXAMPLE # 1:** Your group has **up to** 7 AA meetings a week, the total annual insurance cost would be \$35.00 per meeting x 7 = \$245.00 per year.
