Treasurer Report – Greg B.  For March 2024 Statements of Activity and Financial Position. Please reference the Statement of Activity Actual vs. Budget March 2024 included in the attachments. Highlighted items reflect information in this report.
Thank you to our volunteers, special workers, Office Manager Robin, and staff.
Literature sales were soft for the month at \$6,586 on a budget of \$7,083. [line 4020]
Medallion sales were good at \$4,014 compared to a \$3,125 budget [line 4035].
Group Contributions were outstanding, \$20,940 vs. a budget of \$12,000 [line 4100]. Year-to-date Group Contributions remain ahead of budget by \$11,401. Thanks to all the groups for the contributions to keep the office going for our fellowship.
Birthday contributions were good at \$268 on a budget of \$125 [line 4120]. Get the word out and HAPPY BIRTHDAY!
Faithful Fivers income was off slightly at \$720, as we budgeted \$917 [line4130]. This is a great way for us, as individuals, to directly support CCFAA each month. Sign up today at www.aasacramento.org click on DONATE then FAITHFUL FIVER.
The Insurance Program revenue was \$1,720 versus a budgeted amount of \$792 [line 4127]. Group renewals were due by March 31st, so revenue is seasonal. This variance should decrease as the year progresses. Total Income was up for March at \$35,692 on a budget of \$26,894. [Total Income line]. Year-to-date Total Income is \$21,883 over budget.
Cost-of-Goods-Sold was above budget, \$9,003 vs. \$8,225 [Total COGS]. Strong medallion sales may account for part of the variance.
Payroll Expense was \$9,688, below the budget amount of \$10,998 due to the departure of a staff member. [Total Payroll Expenses].
Utilities expense decreased to \$1,029 versus the \$1,304 budget [Total Utilities]. The year-to-date over budget variance is down to \$495.
Total Expenditures were \$14,254 compared to the \$17,852 budget. The year-to-date total is \$49,697, which is below the \$54,508 budget by \$4,811. [Total Expenditures].
March's Net Revenue was \$12,435 versus a budgeted loss of \$183. Year-to-date Net Revenue is \$23,684, which is \$25,184 ahead of budget [Net Revenue].
Since it is a quarter end, the Statement of Financial Position is presented.  a. Total cash on March 31st was \$180,479. Our prudent reserve of \$101,066 is fully funded. We have more than one month's expenses in the checking account, some of which will be expended for previously approved web site upgrade and computer replacements. Total assets were \$215,568.  b. Total liabilities, consisting of accounts payable (\$10,007), payroll liabilities (\$2,276), accrued paid time off (\$9,660), and sales taxes payable (\$3,141) are \$25,084.

We, as members of Alcoholics Anonymous, are helping to make great investments in the future of our Central Office. Thanks to you and your groups for that.

CCFAA's Unrestricted Fund Balance (equity) was \$190,483, including the year-to- date net revenue of \$23,684.



- ☐ **Group copy of the newsletter By The Way-** Per the Operation Procedures I would like to clarify some misconceptions about who receives the newsletter for the registered groups.
  - 9.11.4 A copy of the "By The Way" is mailed to each registered group at no charge. Any group wishing to receive more than one copy may subscribe for additional copies at the individual subscription rate.
  - 9.11.8 No complimentary copies are mailed to any CCFAA Officer, Delegate, or Committee member
  - To clarify....Each registered meeting/group/fellowship decides for themselves how they will receive their copy of the newsletter and monthly flyers. Some groups have a permanent location, address, or PO Box where they wish all of their correspondence from CCFAA to be mailed year to year so that they do not have to update information annually.

Other groups do not have this option and have their trusted servant's name and address on file for the different communication avenues for mailing such as the Delegates information listed to receive the newsletter and flyer mailings. In these cases, when a trusted servant rotates out of their position the Central Office, not the CCFAA recording secretary, will update the information in the mailing database.

## ☐ By Laws & Procedures (BLOPS) Chair Report – Jim C.

- Attending Jim C (El Dorado Hills Tuesday Night Group), Chair; Melissa P (Group 3)
- Jim presented an outline of things we might focus on for the coming meetings. Jim spoke to Greg B, previous committee chair, who outlined several items that last year's committee had been charged to review, but were unable to complete.
- Regarding the removal of Board members, Bylaws Article 5.3(c)(ii) says that a director can be removed if, "The Director has failed to attend three (3) Board meetings and/or three (3) Delegate Meetings in a calendar year...". Does that mean the director can be removed if they miss 3 board meetings and 3 delegate meetings, or just 3 delegate meetings? What happens if a Director misses 3 Board meetings and 1 or 2 Delegate Meetings? Is the intent to encourage directors to attend both Board and Delegate Meetings? The last sentence of the paragraph states, Director attendance is required at all Delegate Meetings, Election Meetings and Special Meetings of members, and all meetings of the Board of Directors. In light of that sentence, maybe the and/or should just or?

	Operating Procedures (OP) Section 15.7 addresses the hiring of the Office Manager (OM). Section 15.8 addresses dismissal of the OM. Last year's BLOPS Committee started to review these, identified some areas of concern, then stopped realizing that employment law issues were involved and recommended that the Board consult legal counsel. That's where the matter was left. This is now beginning to move forward.
	OP Section 17.2 addresses the election committee and process (17.2.3). The section assumes an in-person Election Meeting (e.g. 17.2.3.8 requires casting written ballots which are given to the teller to count). Perhaps there should be a provision allowing online participation in Election Meetings and the modification of procedures to accommodate that mode of participation. That is how they have been held for the last 4 years.
	Review of Employee Handbook. This was not started, so we would begin from scratch. Any work done here might require consulting a legal advisor. Also to be considered: The Operating Procedures, Section 20.8, specifies that only 6 amendments can be considered at a time; that does not mean in total, but then there is a limit by the calendar in putting things through, in the form of our Delegate's meeting voting structure – Present to Delegates, Hear back concerns from individual meetings, Vote on the third month.  Jim will send copies of all three documents to the committee members. We will be meeting again on 4th Saturday of April 2024 – (April 27, 2024) @ 4:00 PM.
